Numbers are reference to the question numbers in the discussion questions booklet for Discussion Paper 1. 3. Information about domestic violence in all it's forms needs to be taught in high schools predominantly in Years 8-10 while the majority of teens are still in school and before forming serious relationships. There also needs to be a broad education campaign for adults. 7. I am a victim of coercive control. I received approximately 8 hours over a year being able to speak with a social worker after I'd left. I received no other assistance. I did my own research and as a result created the Domestic Violence Information Library (Australia) and also admin a support group Domestic violence support Australia. These peer support groups are the only resource that many women have access to. 8. Generally nothing on a large scale with any certainty. While things may be done right, I don't often hear about them within the Facebook groups and I certainly didn't experience anything done right. 9. Everything needs to improve. Funding, education for service providers, police, magistrates, lawyers. Perpetrators need concrete consequences - it's basically proven that no reform programs will work and they continue to perpetrate and get away with it. 10. Funding and actual services in regional areas. More access using the internet. 11&12. Perpetrators are beyond help. Sentencing needs to be harsher and they need to be kept away from their victims. 13. Perpetrators need to be kept away from victims. 25. Has to be mandatory. 27. Waste of time. No programs will help. 41. Police could actually believe a victim and not dismiss and victim blame (as happened to me). 45. More trained and assessed suitable dv liaison officers. The DVLO I dealt with should not have been in the position. 50. Yes. They cannot protect others when they have been perpetrators. 51. Yes. A history of orders against a person is a warning sign that can't be ignored. Generally, I am concerned that current laws are not being enforced. New laws may not be the answer. Also concerning me is the ability of perpetrators to manipulate laws and have them used against victims. Misidentification of perpetrators would take on a new level of danger for victims.
